Introduction

This procedure describes the steps required to install and run the latest version of the PANalyzr protocol analyzer software on a macOS machine.

System Requirements

The following system settings and software are required for the PANalyzr protocol analyzer software:

- Intel Mac running Catalina (10.15.6 or 10.15.7) or Monterey (TBD)
- 10GB free hard drive space
- Internet access (to download required package dependencies)

Install Wireshark (Prior to installing the PANalyzr software)

Note: The process used to install, upgrade or downgrade Wireshark on the computer could remove existing Wireshark preferences and configuration files. A backup of these files, if they exist, is strongly recommended before running these commands.

- Download the file *Wireshark 3.6.2 Intel 64.dmg* from the website https://www.wireshark.org/#download
- Double-click on the downloaded Wireshark install file
- □ In the *Wireshark 3.6.2* window, drag the *Wireshark* icon to the *Applications* folder icon
- □ (If applicable) Click on the "Replace" button in the dialog window that is displayed
- □ When the 'Copying "Wireshark" to "Applications" task completes, close the Wireshark 3.6.2 window

Install the PANalyzr Software

The steps below should take approximately 15 minutes to complete, depending on how many of the required packages are already installed on the machine

- Download the *PANalyzr_0.9.0.dmg* Disk Image file
- □ Open the *Disk Utility* app
- □ From the Disk Utility menu, select Images → Convert
- □ In the Open window, select the file **PANalyzr_0.9.0.dmg**, then select the **Choose** button
- □ In the next window, choose **read/write** from the Image Format pull-down menu
- □ Click the **Convert** button
- □ Click the **Done** button
- □ Quit the *Disk Utility* app
- Delete the *original* **PANalyzr_0.9.0.dmg** Disk Image file
- □ Using Finder, navigate to the correct folder and double-click on the file *PANalyzr_0.9.0* converted.dmg
- □ On the *Desktop*, double-click the newly mounted *PANalyzr_0.9.0* Volume
- Double-click on the *PANalyzr-Setup* icon
- □ At each of the "Okay to upgrade to newest version of <package name>" prompts, hit the Enter button

Note: The PANalyzr application requires homebrew be installed on the computer, as well as the packages gnutls, libgcrypt, gcc, libusb, python, glib and jsoncpp. The PANalyzr setup will attempt to install them if they are not already installed, or just reinstall them at the latest version if they are. The user can enter "n" or "N" at each prompt to not allow the installation, but the PANalyzr software may not operate correctly.

□ When the message "PANalyzr Setup Complete!" message is displayed, close the Panalyzr-Setup terminal window
